



Notre Dame Catholic Primary School Schedule of Fees & Charges 2025

Enrolment Application Fee

This is a non-refundable payment of **\$35.00** (including GST).

Enrolment Acceptance Fee

This is a **\$100.00** fee which shall be credited to the school fee account.

Annual School Fees

The total annual school fees are split between student fees and family fees. To calculate the total school fees payable for 2025, you will need to add the total student fees and the total family fees.

Student fees are made up as follows.

- Tuition:**

Family Fees 2025

The following fees are charged as a **per family** fee and are in addition to the annual student fees.

Building Levy

The fee is a contribution for the year **per family** and is shown on the account as a separate item.

4 Year Old Kindergarten	\$179
Pre-Primary to Year 6	\$299

Fees collected will contribute towards expenditure on capital improvements and maintenance as well as installing and maintaining fixtures. This fee is determined by Catholic Education WA Limited.

Parents and Friends' Association Levy

The fee is a contribution for the year **per family** and is shown on the account as a separate item.

Fees collected will contribute towards equipment and improvements that will benefit the students. It is important that all parents contribute towards projects in the school.

Discounts for Siblings

The following discounts on tuition fees will apply.

20% per year for the second child
40% per year for the third child

Please note: Where four children are enrolled at the school from the same family, **NO** tuition fees will apply to the fourth child.

SIBLING DISCOUNT DOES NOT APPLY TO 3YO KINDERGARTEN.

In following the recommendation from Catholic Education WA Limited, our fees have increased by 5.5% for 2025.

Payment Options for Annual Fee

The annual fees are made up of the student fees plus the family fees.

1 3 YEAR OLD KINDERGARTEN.

Payment options are:

- (i) **One annual payment** **\$2,660 or \$5,320**
- (ii) **Four instalments over Terms 1, 2, 3 and 4**
This fee is payable, **prior to the start of each term**, at \$665 or \$1,330 per term.

2 KINDERGARTEN TO YEAR 6.

Payment options are listed on your school statement which will be sent to you via email in mid-February 2025. If you choose to pay in full by 28 February 2025, the 5% discount on tuition fees only will be listed on your statement and the reduced fee payable will show in the option 1 line.

Option 1: 1 Instalment - Due 28 February 2025 (with 5% discount on tuition fee only).

Option 2: 2 Instalments - Due 28 February and 28 July 2025.

Option 3: 3 Instalments - Due 28 February, 28 May and 28 August 2025.

Option 4: 4 Instalments - Due 28 February, 28 May, 28 August and 28 November 2025.

Option 5: 10 Instalments - Due monthly from 28 February 2025.

Option 6: 20 Instalments - Due fortnightly from 28 February 2025.

The school provides many alternatives for the payment of fees which include, direct debit, credit card (Visa and Mastercard only) and BPay. The school does not charge any fees for use of credit cards.

Health Care Card (HCC) Holders

In accordance with Catholic Education WA Limited policy, the school provides considerable assistance with school fees. In 2025, this is made up of the tuition fee and amenities levy component of the student school fees. In addition, discounts to the building levy will apply to all HCC card holders. Health Care Card holders must apply each year, **by the end of Term 1**, and the discount applies to that year only. HCC card holders must re-apply at the beginning of each subsequent year.

Additional Information

Camp

The costs of the compulsory Year 6 camp is \$400.00 and is shown on the account as a separate item.

Insurance

Our students are covered with Chubb Insurance Australia Limited. Parents may wish to take out additional cover, which may offset some of the additional costs associated with injuries.

As the school requires student participation in the sports, physical education programs and camps, adequate insurance cover has been included in the school's general insurance policies to cover major accidents and public liability while students are involved in school organised activities.

Notice of Withdrawal

Parents are required to give a **FULL-TERM** notice in writing if they intend to withdraw their son or daughter from the school, during the course of the school year. Please note that in the event of failure to advise the school of withdrawal, a full-term fee may apply.

Further Information

The payment of school fees forms part of the Offer and Acceptance contract signed by parents when a student is enrolled at Notre Dame Catholic Primary School. Parents seeking further information should contact the School Bursar.

Assistance with Fees

No student is excluded from this school because of the inability of his or her parents to pay the full annual fee. However, parents are expected to contribute to the best of their ability. The following fee assistance may apply:

- **Concessions**

The School Advisory Council is sympathetic towards parents with genuine needs who require financial assistance. Parents seeking a concession should contact the Bursar to arrange an appointment with the Principal. All concessions are re-negotiated on an annual basis.

- **Health Care Card**

In accordance with Catholic Education WA Limited policy, the school provides considerable assistance with tuition fees. Effective from January 2020, a discount is given to the tuition fee, amenities levy and building levy component of the composite fee. Please see the Bursar by 30 April 2025 to apply for the discount. This applies to new HCC holders as well as existing cardholders.
